ELIGIBILITY

EUROPEAN OPEN COMPETITION: TOP FUEL BIKE, FUNNY BIKE, PRO STOCK BIKE, COMPETITION BIKE, SUPER STREET BIKE, 9.50 BIKE, 8.50 BIKE, JUNIOR DRAG BIKE, SUPER TWIN TOP GAS, ET BRACKET

BIKE/NAST

This competition is open to adults and minors riding solo machines being holders of a current competition licence of National or Clubman level issued by the ACU or the Scottish ACU or holding a licence issued by a European Community FMN and endorsed for use elsewhere in the European Community, including repatriation and be a member of SPRC or APIRA. Riders with licences issued by other European federations other than the ACU/SACU must have start permission and insurance from their licence issuing federation.

MACHINES Must conform to the eligibility rules of the current Santa Pod Racers Club Official Yearbook and ACU

Standing Regulations (Drag Racing) in the following classes:

COURSE

Length of course is 1/4 or 1/8 mile - Course Licence No: 54

ENTRIES

Entry forms are supplied by the Club. Each entrant must fill in full details of his or her name and address, licence number and sign.

ENTRY FEE

The entry form and fee of £150.00 or £175.00 must arrive no later than 12 noon on Friday, 9th March 2018. All cheques and postal orders made payable to Santa Pod Racers Club. Payment of the entry fee can be made by Credit Card subject to a surcharge by completing the appropriate section on the entry form. The entry form and payment should be sent to SPRC, P O Box 12, Rushden, Northants, NN10 0ZU. In addition an Electricity fee of £60 for providing single phase 240 volt, 13 amps will be charged to all competitors. Competitors wishing to upgrade to 3 phase 380 volt/16amp have to request this on the entry form and will be charged an additional fee of £100. If not requested in advance on the entry form an additional fee will be incurred at the event. An entry may be made by fax provided it is received before the closing date and entry form with the entry fee is despatched simultaneously. Cheques for entry fees must not be posted dated after the closing date. The entry form and payment should be sent to SPRC, P O Box 12, Rushden, Northants, NN10 0ZU. The club reserves the right to refuse any entry and abandon, cancel or postpone the meeting or alter the programme of events and awards.

ENTRY FEE REFUND

Is at the discretion of the Club. And only if a cancelation is received 3 days prior to the event start date. The Organisers undertake to insure each competitor, indemnifying him against any third party claim made, arising out of the races or official practice excluding claims by other competitors, entrant, sponsor or mechanic.

FIRE EXTINGUISHERS

All competitors must have a fire extinguisher within their pit area to conform to Health & Safety requirements. This is in addition to any fire extinguisher systems within race vehicles.

TECHNICAL CONTROL

The competitor is required to produce to the Technical Official his or her machine and protective clothing, helmet, gloves, boots, leathers, licence and identity tag.

TECHNICAL CONTROL & SIGNING ON

Will start at 7am Friday morning.

QUALIFYING

TOP FUEL BIKE, FUNNY BIKE, COMPETITION BIKE, PRO STOCK BIKE & SUPER STREET BIKE will all qualify up to an 8 bike maximum field. Over 8 will qualify for set fields on the following basis: 9-12 qualifiers – 8 bike field, 13-14 qualifiers – 16 bike field, 24+ qualifiers – 32 bike field. 9.50 BIKE, 8.50 BIKE, JUNIOR DRAG BIKE, Super Twin Top Gas and ET Bracket Bike will all run first round.

PRACTICE & PROGRAMME OF THE MEETING

The following minimum number of qualifying sessions will be held: 2 day qualifying – 4 sessions (2 per day), 1 day qualifying – 3 sessions, track conditions permitting. There will be compulsory alternate lane qualifying. For first qualifying run pairs should be run where possible, lane choice for first qualifier is at the discretion of the start crew and singles should be restricted to one only per session, track conditions permitting. A valid qualifying run must be made under engine poser and an ET and/or TS must be recorded. If the race distance is reduced before the conclusion of qualifying then the positions in the ladder will be established over the distance for the last complete round of qualifying. Once qualifying has concluded and a ladder has been established, pairings will not be changed. However, should a qualified bike and rider be unable to make the first round of eliminations (not reach the burnout water area) an alternative will be inserted in their place. The quickest non-qualifier will take the first available space, the second quickest non-qualifier the next available space and so on.

METHOD OF STARTING

Green light in pairs where possible.

AWARDS

Trophies will be awarded to the Winner and Runner Up in each class. Prize monies will be awarded to all eligible competitors via BACS where possible within 10 days of the completion of the event, foreign competitors will be paid via card payment (if applicable).

PRIZE GIVING

Will be awarded in all classes 30 minutes after the final race.

Reference should be made to the Sporting Code of the ACU, 2018 edition.

ENTRY DECLARATION: I the undersigned apply to enter the event described above and in consideration thereof:

- I hereby declare that I have had the opportunity to read, and that I understand the National Sporting Code of the ACU, the ACU Standing Regulations, such Supplementary Regulations as have or may be issued for the event, and agree to be bound by them.
- I declare that I am physically and mentally fit to take part in the event and I am competent to do so. I confirm that I understand the nature and type of event I am entering and its inherent risks and agree to accept the same notwithstanding that such risks may involve negligence on the part of the organisers or officials.
- I confirm that I am not currently suspended from ACU permitted competition nor on the ACU Stop List as a result of incurring a Concussion injury.
- I accept that insurance arranged on my behalf by the organisers of events that I may enter specifically excludes liability between the participants. I understand that this form may be used in litigation as evidence that any serious injury will be principally the result of my voluntary decision to engage in a high risk activity.
- I consent to details of any injuries I may suffer at this event being passed between all medical services and the Clerk of the Course.
- I consent to the collection and retention of my personal information by the ACU.
- I confirm that the machine(s) as described below which I shall participate on shall be suitable and proper for the purpose. I confirm that I am eligible to participate on the machines for which I have entered.
- I confirm that if any part of the event takes place on a public highway, the machine(s) described below shall be insured as required by the Road Traffic Acts, or equivalent legislation, and that they will comply with the regulations in respect thereof.
- I accept responsibility for any items borrowed from the Organiser during the course of the event. These items include but are not restricted to (safety clothing, transponders, and accessories). I understand that I am liable for the cost or replacement of any items lost or not returned and non-payment or non-replacement of items borrowed may affect my entry into subsequent events.
- I confirm that I have not been refused an ACU Licence, nor had an ACU Licence suspended, nor have I been excluded from any ACU competition.

It is therefore essential that you give us your exact width and length dimensions so we can try to plan it as properly as possible, please make the effort to measure your combination so that you can give us the exact measurements. We will not guarantee a wider pit space than 7.00 meters and that will include your awning. Those of you who have a wider combination will not be able to use your awning here at Santa Pod and I advise you to make contact with us a minimum of 3 weeks prior to the event to see if we can sort something out, but only after you have filled in the extra pit space form. Thank you for your help.
